Mayor Donnellon opened the meeting at 7:00 pm with the Pledge of Allegiance followed by the Invocation.

The clerk read the roll. Mr. Kelly, Mr. Daily, Ms. Downs, Mayor Donnellon, Mr. Camp, Mr. Feldhaus, Mr. Daily. All members present.

Approval of Minutes

Ms. Downs motioned to approve the minutes from the October 2, 2023 Council Meeting. Mr. Daily seconded the motion. Motion carried by a unanimous voice vote.

Presentations

Members of the Deer Park-Silverton Joint Fire District made a presentation about the Lucas CPR device. The machine is used to administer mechanical chest compressions, which both frees up a paramedic and administers consistent chest compressions. The Deer Park City Council paid for two machines for the fire district. Mr. Patrick Hennigan was present to thank the members of the Deer Park-Silverton fire district for the lifesaving procedures they administered to him on August 17th.

Safety Committee Chair Tom Camp -

Lieutenant Jordan reported the Police Department is now fully staffed.

<u>Public Works Committee Chair Kathy Downs</u> –

Ms. Downs gave the following updates on Public Works projects:

- Crews will begin milling and resurfacing Maple, Brookline, and Summit on October 16th. If the Water Works portion on Hegner is done by next week, the resurfacing of Hegner will also be completed.
- The crews are preparing the equipment for leaf collection.
- The new dump truck has been delivered.
- The waterworks project is expected to move to Plainfield Road, north of Montgomery Road on Tuesday October 24th. Any residents or businesses impacted by road closures will be notified.

Park Board Committee Chair Mark Feldhaus -

Mr. Feldhaus reported BooFest was a great success. The event raised approximately \$2000.

Mr. Feldhaus clarified a comment that was made to a member of the audience at the last council meeting. Mr. Feldhaus explained that he was speaking to resident Jay Easton in the audience, not a spectator in the audience J. Janus. At the October 2nd council meeting, Mr. Feldhaus invited Mr. Easton to help scare the children at BooFest. Mr. Feldhaus' comments were made in jest, directed only at Mr. Easton. Mr. Feldhaus was extremely disappointed to find out that false accusations were made against him and sent out via email to a large number of people. Mr. Feldhaus also addressed email responses sent by residents Joyce Kremer and Beth Carpenter, again noting that his comments were made to Mr. Easton, not Mr. Janus. The email responses to the incident were based on the assumption that Mr. Feldhaus had addressed Mr. Janus, which was simply not true, and unfairly and unnecessarily painted a distasteful picture of Mr. Feldhaus.

Diversity & Inclusion Steering Committee - Neil Kelly

Mr. Kelly reported committee met on Thursday, October 26. The committee expects to be ready to present to council in November. Mr. Kelly read the mission statement aloud, at the request of Mr. Arvin. All are welcome.
