Presentation: Gage Bradford

Mr. Gage Bradford, from the Hamilton County Storm Water District presented to council briefly. Mr. Bradford stated that recyclables send less waste and explained that the storm water district is mandated by the state to update the plan every 5 years with communities needed to ratify it. There are grants for 1 million every year. Mr. Camp asked if there is a website. Mr. Bradford stated that he is leaving a document for council to review.

<u>Public Comment – Citizens and Guests</u> –

Joe Comer 4629 Webster Avenue – Mr. Comer addressed council about an idea he has had for some time now and has talked about with Mayor Donnellon as well. Mr. Comer explained that he and the late John Perin had great dislike for each other however doesn't think there has been anybody who cared for the City of Deer Park more, especially Chamberlin Park, than John Perin, who lived and worked hard for the Days in the Park Festival and dedicated many years as Park Board Chairman before spending a few years as a Deer Park Councilman. Mr. Comer would like to see the entrance to Chamberlin Park, off Matson, named John Perin Boulevard, John Perin Parkway or John Perin Way. The pavement needs to be redone and fixed up however once done and named Mr. Comer would like to see it dedicated as well.

Michael Ziegelmeyer 3919 Hemphill Way - Mr. Ziegelmeyer suggested that there be "No Parking" on both sides of Hemphill Way as there have been many issues there.

Margie Hillman 3909 Hemphill Way - Ms. Hillman stated that there are vehicles parking against a fence on the street, even though there are signs that say, "No Parking". There are also several instances where neighbors are flying through the intersection.
