Orchard Lane Project

Mr. Lehane stated that the Orchard Lane project will start soon as it is raining today.

Correspondence (Clerk of Council) & Miscellaneous – Ms. Perin read a letter to City Council from the Deer Park Silverton Joint Fire District thanking council for the generous donation of two LUCAS automated CPR devices. Fire districts are not eligible for CARES Act funding and these vital pieces of equipment will allow personnel to safely and effectively deliver CPR to patients by limiting physical contact with patients that may be positive for a number of communicable diseases.
