## Park Board Committee \*Chairman Mark Feldhaus

Mr. Feldhaus announced that the Friends of Chamberlin Park Armchair Races was a complete success as it made around \$2000.00 for the park. The annual Easter egg hunt is on April 1, 2023 at 11:00 am. Dr. Jetter announced that we received \$150,000 for starting the design for the music pavilion. A meeting will take place with the design team in the next 2 weeks. The rest of the funding is in progress.

#### **Establishment of Steering Committee of Diversity and Inclusion**

# **Reports from Other City Officials**

**Solicitor** – Mr. Pacheco stated that at 6:30 pm this evening a public hearing on zoning code changes took place. City council directed Mr. Pacheco and Mr. Stoker to make some tweaks on the food truck regulations. These changes will be presented at the next public hearing on April 17, 2023 at 6:00 pm.

**City Manager** – Dr. Jetter announced that we have completed the recycling report and once compiled we will receive some money back. Last year we received \$5,000. We should not see any more than that this year however we will be able to use this for some things in the park.

We are still working on bids for the park walkway. Ms. Westmark asked if they will be able to expand the in the narrow area. Dr. Jetter explained that it will not be as wide as the new portion we have now but that the walkway should be able to get done this year.

Dr. Jetter will not be in tomorrow, March 7, 2023, due to wife's surgery.

Mayor Donnellon questioned if the walkway will be able to extend behind small diamonds. Dr. Jetter replied that we have \$80,000 to spend and not sure this could fit in with that budget.

Mayor Donnellon commented on the speeding he observed behind the school in community center parking lot entrance and suggested a speed bump be installed there. Dr. Jetter will put in specifications. Mr. Kelly mentioned that when entering the parking lot on the sidewalk in either a wheelchair or a stroller from Plainfield Road, there is a drainage pipe that causes one to go out into driveway to get around it and wants to know if this could also be corrected with the parking lot improvement project.

Dr. Jetter said that the city has never had an easement agreement with the railroad for a pedestrian crossing and he has been in contact with the railroad is waiting to hear back. For the city's future protection, we need all three easement agreements to mirror each other for Duneden, Clifford and at 8211 Blue Ash Road, near the businesses, so that the process does not have to be gone through again where the railroad tears out a crossing and does not repair it.
