Public Works Committee: Chairman Dan Lehane
2020 Road Program

Mr. Lehane announced that in 2020 the following streets are part of a mill and pave repair: Webster, May, O'Leary, Orchard. The total cost is \$200,000 with Deer Park's share to be \$100,000. St. John's Terrace is under review per Mr. Jetter.

Legislative and Finance Committee: Chairman Charles Tassell

Mr. Tassell noted that we have nothing to report at this time other than the information from the Public Hearing, held earlier tonight. Mr. Tassell motioned to refer back to Zoning. Mr. Rapp seconded the motion. Motion carried by a unanimous vote of the Legislative and Finance Committee.
