### **Standing Committee Reports**

Legislative and Finance Committee Chair Chris Westmark

Ms. Westmark asked Clerk of Council to read by title only.

RESOLUTION 2024-1 Authorizing the City Manager to purchase a New 2023 Dodge Durango V8 AWD with Emergency Equipment and to take all action necessary to effectuate such purchase. Discussion ensued.

Ms. Westmark made a motion to pass the resolution, Mr. Camp seconded the motion. A roll call vote was held Mr. Camp, yes, Ms. Downs yes, Mr. Feldhaus yes, Ms. Kohorst yes, Ms. Westmark yes, Mayor Donnellon yes. (Mr. Kelly not present). Resolution 2024-1 passed.

The car will be in service within 60 days and once in service the car it is replacing will be placed for auction, funds are coming from the Police fund. The fund has about \$80,000 the car will cost \$56,000 including the emergency equipment.

Mr. Feldhaus discussed the December Police report,. During 2023, there were 9998 calls for service, 316 arrests.

It was suggested residents keep their garage doors closed to limit theft.

Vacant Residential property ordinance

Mr. Pacheco suggested council take the three paragraphs Gerry Stoker wrote and incorporate into the city's current commercial ordinance. Mr. Pacheco will send a redline copy to council with the changes by Monday January 29 to look at for discussion at the Feb 5, 2024, council meeting.

Mr. Pacheco reminded residents and council the ordinance is about compliance and not citations and fees.

Discussion ensued; Mr. Pacheco stated the cities he works with also only do once in the beginning of the meeting. ### City Manager

Dr. Jetter stated the finalized bid documents will be presented to council at the February 5, 2024, meeting.

The bid was a good one and there should be funds left for sidewalks and curbs. He stated he has received complaints around the watermain project, there is a timeline on the city web page for completion.

The city has received complaints on the Gail and Galbraith intersection. The county wants \$25 million dollars to do work there. The city is looking at other options.

Dr Jetter stated they are working on a new budget, not spending what we don't have.

He stated the Service Department did an excellent job with snow removal last week.

He shared SORTA recognized the city on our project and Neil Kelly was appointed to the SORTA board.

Mr. Kelly was recommended by the County Commissioners. Congratulations Mr. Kelly.
