City Manager:

There will be a Public Hearing Monday Jan 19th, 2026, at 6:00 PM Council Chambers in regards to what the Zoning Commission passed. 8028 Blue Ash Road and 4325 Schenk Ave. Looking at plans for 17 townhomes concept plan, PUD plan, the house on Schenk will be torn down and used for green space. These townhomes are self-funded. Jan 13th, 2026, Dr. Jetter is meeting with Western Southern grant commission about projects for Gateway Signs (3) and with UC outdoor fitness. UC is giving us \$65,000 toward the project but we will need additional funding, the state asked us to do this project. On Jan 20th, 2026, Dr. Jetter will deliver the State of the City at the Block Watch meeting. Dr. Jetter may be having surgery on shoulder, more to come Sheena and Dr Jetter closed the books on the year, and did the PO for the new Year. It is a very tight budget, expenses keep growing. We will still need to purchase a Police cruiser this year. The city is very reserved with road projects unless we receive funding from Sorta. The Blue Ash Road final trace drawing is almost complete. Dr. Jetter told Duke we want new metal poles. The IT changeover is extended another month, more problems with vendors wanting ACH payments, so we need secure sites to do that.
