Ms. Westmark presented the December JEDD report, the city earned \$49.31, YTD \$387.16 Ms. Westmark made a motion to accept the JEDD report; Mr. Camp seconded the motion, motion carried.

Ms. Westmark presented the December JEDZ report, city earned \$12,511.63 YTD \$128000, Ms. Westmark Made a motion to accept report, Mr. Feldhaus seconded the motion, motion carried.

Ms. Westmark presented the December Auditor Report, Ms. Westmark made a motion to accept at Submitted, Mr. Kelly seconded the motion, motion carried.

## **Safety Committee Chair Tom Camp:**

Mr. Feldhaus presented the December Police report, there were 882 calls for service, YTD 12,177 calls to service, and 405 arrests. Mr. Camp presented the Joint Fire District report, there were 96 requests for service with just Deer Park. 337 in the district. For YTD 2024, 1268 calls for service, the district had 3719 calls. A decrease in 400 calls for service from 2023

#### **Public Works Committee Chair Kathy Downs**

Ms. Downs recognized the wonderful job the service department did during the large snow event. Our city does a much better job the other cities.

#### Park Board Committee Chair Mark Feldhaus

The volunteer party was held the prior Saturday, well attended and lots of fun. Next armchair races will be February 22nd, 2025. Doors open at 6 pm post time 7pm. This event raises money for Friends of Chamberlin Park that support our park. Friends of Chamberlin Park are donating \$10,000 to the Pavilion sound system.

**City Manager** – decision was made to not put a Police operating levy on ballot, it would have impacted the homestead tax credit many of the residents receive. The city has received \$30,000 back from the state for the Pavilion.

There will be a new phone system in the city offices which has reduced the costs to the city.

The city was notified powder substances have been seen in the mail lately, city is using gloves to open all mail. Sycamore Township is deciding on the Kenwood rd. traffic study. They asked Duneden to be opened as a cut through, Dr. Jetter said no.

Dr. Jetter is looking into computer issues in the city offices. And he wanted to celebrate the maintenance department as well for the amazing job they did with the snow event. A couple trucks had mechanical issues, but the department handled them and got the trucks back out quickly.

There was an issue at Amity, but it was handled.

As I was researching & organizing the way Deer Park Venue Rentals have been processed/handled, I discovered several things that are either inconsistent or are causing Deer Park to lose revenue.

Please note that fees haven't been updated since 2008.

# Recommendations for policy changes and rental rate changes -

Shelters – Resident Fee - \$50

Shelters – Non-Resident Fee - \$125

Shelter Beer Permit - BJ will discuss with City Solicitor due to alcohol liability issues.

Community Center – Resident Fee - \$300 for 8 hours of use on the same day.

Community Center – Non-Resident Fee - \$850 for 8 hours of use on the same day.

Community Center – \$35 per hour over 8 hours of use, on the same day.

Community Center – To set up the night before – Begins at 6:00pm – 50% of Event Day fee.

Community Center — 2 consecutive day rentals — 8 hours per day — 10% discount.

Community Center - Democrat, Republican, REI Clubs - \$260 annually for one meeting/month.

Community Center – Weekly events - \$1000 annually for one event/week (52 events/year).

\* Additional events will be charged \$260/event.

Former Employee Fee - No longer at no charge. They will pay the Resident Rate.

Deposit must be paid at the time of reservation, or the facility will not be reserved. Rental fee must be paid by 30 days prior to the event date or reservation will be cancelled.

# Deer Park City Schools -

If the event is sponsored by Deer Park City Schools (therefore supported by Deer Park taxpayers), it will be at no charge (We need a written statement from DPCS stating that they are sponsoring the event).

If the event is NOT sponsored by DPCS, then there will be a normal fee for rental.

Private School Rental Fees – 50% of Resident Fee and they need to provide a liability waiver.

Sports Teams and Leagues -

Fees MUST be paid BEFORE the season, not after.

Field Use Fee - \$10 per game.

Field Light Fee - \$20 per hour (no increase).

Created a field use application and added liability waivers, to be signed by league commissioners & provided to the City BEFORE the start of the season.

Created a game schedule chart so we know how many games are being played in the park BEFORE the season begins.

Dump Truck Fee - \$200.00 (includes Rumpke's dump fee & labor).

Residents who reserve a facility for non-residents so they can pay a lower rental fee — If someone rents a venue for a non-resident, the resident MUST be onsite the entire duration of the rental (can be verified by Deer Park at any time). If the resident is not onsite, they'll be billed an additional \$550 (up to the \$800 non-resident fee).
