- 1) Will be responsible for all persons in the group or organization using the facility
2) Assumes liability for any damage done to the facility during contracted hours.
3) Will observe all rules, including, but not limited to the following:
A. All litter and debris must be picked up and area cleaned immediately after use. A separate \$25 (check or cash) is required for a cleaning deposit. Will be returned to you if facility is clean. (Checks are shredded unless requested).
B. No motor vehicles in the Park.
C. Park closes at dusk.
D. No intoxicating liquor or beer in park unless a permit is issued by the City. The fee for a beer permit is \$10.00.
E. No abusive language.
F. No bicycles, mopeds, or motorcycles in the Park.
G. No playing golf in the Park.
H. No horses in the Park.
I. Pets must be on a leash as all times.
J. No archery or target practice in the Park.
K. No rain checks issued.

I have read and understand the above policies and regulations and agree to comply with the same.
